The conference is organized by alumni and partners of the educational programme "Lawyers for the rule of law. Education and professional training". The programme is a unique place aimed at enriching lawyers with knowledge necessary for daily law practice as well as at preparation on legal assistance for those, who are made to apply to international judicial and quasi-judicial bodies because of military actions and the human rights crisis.

The programme includes a set of materials that orient the participants of the training to comprehend and implement approaches, initiated by UN Special Rapporteur on the Independence of Judges and Lawyers. Report "The promise of legal empowerment in advancing access to justice for all" is oriented at the improvements of the effectiveness of access to justice by focusing on the interests of the people. The Special Rapporteur suggests not to limit ourselves to a "superficial approach" and "not to persist in maintaining the usual methods of work".

The conference is designed to present and discuss best practices and support human rights lawyers who have already started implementing these methods in their activities.

Joint training is both a platform for interaction between lawyers from the region and serves to unite them.

The mutual exchange of information contributes to the disclosure of knowledge about international standards and existing legal mechanisms. In a region where non-legal methods of conflict resolution are becoming more widespread, the work of human rights lawyers in the sphere of public justice will contribute to the fight against selflessness and restore confidence in international law.

The solidarity of the training participants is important to counter the pressure of authoritarian states on the work of human rights lawyers and interference into the activities of professional bar associations. Interaction and cooperation with bar associations of European countries makes it possible to elevate the role in the realization of the right to protection and access to justice in these countries.
